Chief Masters Directive 3 of 2012

1. Purpose

The purpose of the directive is to ensure a uniform approach by Masters in respect of the matters listed below.

All previous Master's Directives on points addressed by this Chief Master's Directive are revoked.

2. Motivation / Background

A number of role players have approached my Office for clarity on certain matters. As part of my statutory obligations I have decided to provide the following guidelines to ensure a uniform approach by Masters to the matters raised.

3. The following has been decided:

3.1 Uniformity in issuing of Letters of Executorship and Letters of Authority in Deceased Estates

It came under my attention that not all offices are using the same format of the J170 (Letter of Authority) and the J238 (Letter of Executorship).

In order to ensure uniformity throughout the country, PEC was requested to create e-forms of the abovementioned templates which is now available on Djini.

The attached forms must be used by all offices when appointing an Executor or Master's Representative in a deceased estate:

- i) J170 (Letter of Authority) : **Annexure A**
- ii) J238 (Letter of Executorship): **Annexure B**

4) Effective date

This Directive will come into effect as from 9 July 2012.
