CHIEF MASTER'S DIRECTIVE 6 OF 2012

PREFIXES FOR IDENTIFICATION OF OFFICES IN THE MASTER OF THE HIGH COURT

1 PURPOSE

The purpose of the directive is to ensure a uniform approach by Masters and give guidance to public and the industry in respect of the matters listed below.

This Directive recalls Circular 1 of 2004 and amends Directive 1 of 2012 as well as all previous Master's Directives on points addressed below, with effect from date of signature hereof.

2 MOTIVATION/BACKGROUND

- 2.1 A number of role players have approached the Office of the Chief Master for clarity on the prefixes to be used when referring to the different Master's Offices, especially with regards to the newly established Master's Office in Nelspruit.
- As part of my statutory obligations I have decided to provide the following guidelines to ensure a uniform approach to the matters raised.
- 3 Prefixes for Estate Duty Assessments and Insolvency Files
- 3.1 The following prefixes must be used in identifying Insolvency files in the

various offices, as well as on all Estate Duty Assessments:
